WHEREAS, the Housing Authority of the Town of Guttenberg ("Housing Authority"), a public entity organized and existing pursuant to Title 24 of the Code of Federal Regulations, the Department of Housing and Urban Development ("HUD"), and the laws of the State of New Jersey has determined that a payment is owed to APM Management Consulting, LLC for Interim Executive Director services; and

WHEREAS, specifically, the Housing Authority publicly advertised and issued a Request for Proposals ("RFP") for a consulting company to provide Interim Executive Director Services for the Housing Authority; and

WHEREAS, in accordance with that RFP, the Housing Authority awarded a contract to APM Management Consulting, LLC to perform such services for a 6 month period at a rate of \$4,000 per week; and

WHEREAS, APM Management Consulting, LLC submitted an invoice for services performed in the month of May in the amount of \$16,000.00; and

WHEREAS, APM Management Consulting, LLC submitted an invoice for services performed in the month of June in the amount of \$16,000.00; and

WHEREAS, the Board of Commissioners has found that APM Management Consulting, LLC has admirably performed its contractual duties to date to provide Interim Executive Director Services; and

WHEREAS, the Housing Authority has certified that it has available funds to pay for such services; and

WHEREAS, upon review, it is recommended that the Guttenberg Housing Authority issue payment to APM Management Consulting, LLC for Interim Executive Director Services performed in the months of May and June in the total amount of its invoices of \$32,000.00;

NOW THEREFORE,

BE IT RESOLVED, that the Board of Commissioners of the Housing Authority of the Town of Guttenberg does hereby approve and authorizes the payment of both the May and June invoices from APM Management Consulting, LLC for Interim Executive Director Services performed in the total amount of Thirty-Two Thousand Dollars (\$32,000.00); and
