AND LEGAL COUNSEL TO NEGOTIATE AN INTERLOCAL SERVICE
AGREEMENT WITH THE TOWN OF GUTTENBERG FOR THE PROVISION OF
PARKING ENFORCEMENT SERVICES IN GUTTENBERG HOUSING AUTHORITY
PARKING LOTS

WHEREAS, the Housing Authority of the Town of Guttenberg ("Housing Authority"), a public entity organized and existing pursuant to Title 24 of the Code of Federal Regulations, the Department of Housing and Urban Development ("HUD"), and the laws of the State of New Jersey, has determined that it has a need for parking enforcement services; and

WHEREAS, the Town of Guttenberg has the ability to provide parking enforcement services to Guttenberg Housing Authority parking lots; and

WHEREAS, the Housing Authority wishes to enter into an Interlocal Service Agreement with the Town of Guttenberg for the provision of parking enforcement services in Guttenberg Housing Authority parking lots; and

WHEREAS, pursuant to N.J.S.A. 40A:11-5(2), a contract for parking enforcement services may be negotiated and awarded by the Board of Commissioners "without public advertising for bids and bidding therefor" if it is to be entered into with a municipality; and

WHEREAS, the Board of Commissioners of the Housing Authority has found that approving and authorizing the Executive Director and Legal Counsel to negotiate an Interlocal Service Agreement with the Town of Guttenberg for the provision of parking enforcement services

in Guttenberg Housing Authority parking lots is in the best interests of the Housing Authority and its overall goal of providing quality affordable housing;

NOW THEREFORE,

**BE IT RESOLVED** that the Board of Commissioners of the Housing Authority of the Town of Guttenberg hereby approves and authorizes the Executive Director and Legal Counsel to negotiate an Interlocal Service Agreement with the Town of Guttenberg for the provision of parking enforcement services in Guttenberg Housing Authority parking lots; and

**BE IT FURTHER RESOLVED** that the Board hereby directs the Executive Director and Legal Counsel to report on the proposed terms and conditions of the Interlocal Service Agreement prior to final approval; and

**BE IT FURTHER RESOLVED** that the Board hereby authorizes and directs the Executive Director of the Housing Authority of the Town of Guttenberg to take any and all necessary administrative actions to implement this resolution.
