They are already at the 3<sup>rd</sup> floor, and working their way upwards. The cost is very low, just \$180/day, and the Authority provides all materials and supplies.

- 3. The Executive Director reported that a couple of Authority staff member have taken the Housing Quality Standards course, and both passed.

- 5. The Executive Director reported on partnering with the Town and Horizon BCBS on a local event. Horizon underwrote the entire cost of the event and the Executive Vice President of Horizon attended the event.

RESOLUTION APPROVING AND AUTHORIZING THE AWARD OF A CONTRACT TO CJ VANDERBECK AND SONS, INC. FOR PURCHASE AND INSTALLATION OF

A BOILER IN THE AMOUNT OF \$81,660.

WHEREAS, the Housing Authority of the Town of Guttenberg ("Housing Authority"), a

public entity organized and existing pursuant to the Code of Federal Regulations, the Department

of Housing and Urban Development ("HUD"), and the laws of the State of New Jersey, has

determined that it is in need of a boiler at 6900 Broadway; and

WHEREAS, the purchase and installation cost of the boiler was expected to exceed the

Housing Authority's bid threshold of \$44,000.00 under the New Jersey Local Public Contracts

Law; and

WHEREAS, pursuant to N.J.S.A. 40A:11-4 and prevailing federal procurement

regulations, the Housing Authority requested quotes; and

WHEREAS, in accordance with the Housing Authority's procurement policy, a total of

two (2) bids were received;

and WHEREAS, following the review of all bids received, CJ Vanderbeck & Son, Inc., located

at 240 Marshall Street, Paterson, NJ 07503, was found to be the lowest responsible bid pursuant

to N.J.S.A. 40A:11-4 and N.J.S.A. 40A:11-2; and

WHEREAS, the contract is being awarded pursuant to a "fair and open" process in

accordance with N.J.S.A. 19:44A-20.5; and

WHEREAS, the bid submitted by CJ Vanderbeck & Son, Inc. has been reviewed and deemed by the Housing Authority's Executive Director, qualified purchasing agent, the Engineer and purchasing agent to be responsive and conforming with all requirements as set forth by federal procurement law, New Jersey Local Public Contracts Law, and the request for quotes; and

WHEREAS, the Housing Authority has certified that sufficient funds have been appropriated for the above-mentioned service; and

WHEREAS, the Board of Commissioners has found that it is in the best interest of the Housing Authority and its overall goal of providing quality affordable housing to its residents to approve and authorize the award of a contract to CJ Vanderbeck & Son, Inc.;

**BE IT RESOLVED** that the Board of Commissioners of the Housing Authority of the Town of Guttenberg hereby approves and authorizes the award of a contract to CJ Vanderbeck & Son, Inc.; and
